WHO OWNS YOU??

Why is it, You can be put in jail if your child does not attend Public school? Why is it, If you discipline your child and the authorities are not happy with your choice of discipline they can remove your child from your home?? Because you and your child are wards of the state in which you live. This means you belong to or are subject to someone else's authority. The answer to this madness is called Authentication. When you authenticate your Birth Certificate you become the legal owner.

As the Legal owner, no one can tell you what you can or cannot do with your property.

This should be done for your children as well. You will no longer have problems with vaccinations, Child Support cases, if you add an Affidavit of Identity and a pass-port photo to your document you will not need a Passport, This is now a travel document issued with the full faith and credit of the United States.

First Step

Find out where you need to go in your city to obtain a certified copy of your long form Birth Certificate. It's usually the health department or vital records office. We recommend getting more than one certified copy.

Second Step

Once you've received your certified copies of your long form Birth Certificate, visit your local County Clerks office and have them certify your copies. They will attach a county certification certificate to your birth certificate and certification from the vital records or health department.

Third Step

If your not able to visit your State's County Clerk office, Send your documents to get certified on the State level in a U.S.P.S. Express Mail envelope, making sure you send a stamped self addressed Express Mail envelope with your documents, so they won't tri-fold your documents and return them in a First Class envelope.

Final Step

Send your documents to the Department of State to get "Authenticated" you will need to pick a non-Hague country (Google non - Hague countries for a list, pick anyone of them) If you don't pick a non -Hague country you will receive an "Apostille" as opposed to an "Authentication" from the Department of State. In a nutshell "Authenticated" documents carry more weight and acceptance world wide as opposed to an "Apostilled" document.

Download a DS-4194 form from the US Dept. of State website. Send a \$8. money order for each Authenticated Birth Certificate request.
