

Narcan and Fentanyl Distribution Plan

For CPR/AED & Emergency First Aid Students and Eligible Citizens of the Commonwealth of Pennsylvania

This distribution plan aims to provide lifesaving Narcan (Naloxone) and fentanyl test strips to CPR/AED & Emergency First Aid students and eligible citizens of Pennsylvania to combat the opioid crisis and prevent overdose-related deaths. The initiative focuses on accessibility, education, and community outreach.

Objective

- To equip individuals with the tools and knowledge needed to recognize and respond to opioid overdoses effectively.
 - To distribute Narcan (Naloxone) and fentanyl test strips as harm reduction tools to CPR/AED & Emergency First Aid students and eligible Pennsylvania citizens.

Eligibility Criteria

1.CPR/AED & Emergency First Aid Students:

- All students enrolled in CPR/AED & Emergency First Aid certification courses offered by BUD BROWNSVILLE LLC.
- Must complete a brief training session on opioid overdose response.

2.Eligible Citizens of Pennsylvania:

- Any citizen of the Commonwealth of Pennsylvania who meets these criteria:
 - At risk of experiencing or witnessing an opioid overdose.
 - Parent, guardian, or caregiver of an individual at risk.
 - Community members in high-risk areas identified by public health data.

Components of the Plan

1. Distribution Process

Narcan Distribution:

- Narcan kits will be provided free of charge at the conclusion of CPR/AED & Emergency First Aid training sessions.
- Citizens not enrolled in training can pick up Narcan at designated distribution events, subject to availability and eligibility.

Fentanyl Test Strips Distribution:

- Test strips will be included as part of the Narcan kits to help individuals detect fentanyl in substances and reduce accidental overdoses.

2. Training and Education

- Opioid Overdose Response Training:
- A mandatory 15-minute training session for CPR/AED & Emergency First Aid students, covering:

- Recognizing signs of an overdose.
- Proper administration of Narcan.
- Steps to take after administering Narcan (e.g., calling 911, monitoring the individual).
- Training will include hands-on practice with Narcan trainers.
- Public Awareness Campaign:
 - Inform eligible citizens about the availability of Narcan and fentanyl test strips through community outreach, social media, and partnerships with local organizations.

3. Partnerships

- Collaborate with state and local health departments for funding and resources.
- Partner with local pharmacies and harm reduction organizations to ensure wide distribution and accessibility.
- Work with law enforcement and first responders to create a coordinated response to overdoses.

4. Logistics and Locations

- Primary Distribution Locations:
 - BUD BROWNSVILLE LLC training centers.
 - Mobile distribution units for underserved areas.
 - Community events and public health fairs.
- Tracking and Reporting:
 - Maintain records of distributed Narcan and test strips for program evaluation and compliance with Pennsylvania state laws.

5. Compliance with Pennsylvania Laws

- Ensure all Narcan distribution complies with Pennsylvania's standing order for Naloxone, which allows individuals to obtain and use Narcan without a prescription.
 - Follow state guidelines for the distribution of fentanyl test strips.

Funding and Sustainability

- Seek funding through grants from organizations such as the Pennsylvania Department of Health, the Substance Abuse and Mental Health Services Administration (SAMHSA), and private donors.
 - Establish a donation program where community members can contribute to the initiative.

Evaluation and Feedback

- Collect feedback from recipients and CPR/AED & Emergency First Aid students to improve the program.
 - Measure success through metrics such as:
 - Number of Narcan kits and fentanyl test strips distributed.
 - Reports of overdose reversals attributed to distributed Narcan.
